Terms & Conditions of Rossendale Holiday Cottages Hot Tub Hire:

Health & Safety

- Please enter the spa with safety in mind at all times, checking the temperature first.
- Do not jump in or out or dive into the hot tub.
- Never enter the hot tub with sharp objects. Never use glass or any other breakable items within or near the hot tub.
- Always wear the correct attire when entering the hot tub such as a bathing costume or any swimwear.
- Never wear shoes or heals as this could cause injury and damage to the spa.
- The hirer accepts responsibility for all who use the hot tub that they are in sound medical health. If in doubt, please seek medical advice.
- The hirer takes responsibility that users are not impaired by alcohol or drugs.
- At more than 37.5c you should not spend more than thirty minutes in the hot tub.
- Pregnant women and persons with heart disease, circulatory problems, diabetes or low or high blood pressure should consult a doctor before using the hot tub.

Accidents & Injury

- As the hirer accept and acknowledge that I take full responsibility for the use and users of this hot tub at all times.
- Rossendale Holiday Cottages will not be liable for any accidents relating to use of our hot hubs such as wet surfaces causing slip hazards, running or jumping in and around the spa.
- Rossendale Holiday Cottages prohibits the use of glass items within the hot tub and will not take responsibility for injury caused by glass breakages within or around the spa area.
- Children under the age of 16 must be supervised at all times when using the hot tub.
- Pregnant women must seek medical advice before using a spa. Remember this is a hot tub not suitable as a birthing pool.
- Do not use any electrical items within five feet of the hot tub including telephone.

Using the Hot Tub

- The hirer takes responsibility that users are clean when using the hot tub. All users should shower prior to use.
- Fake tan must not be worn in the hot tub.
- The hirer takes responsibility for making sure the hot tub cover is secured back on the tub when not in use. By signing this agreement, the hirer confirms they have been shown how to remove and secure the lid by a member of staff. You are liable for this hot tub and hot tub cover whilst in your custody for any loss or damage.

Hot Tub Cleaning Protocol

- The hot tub is emptied and cleaned between guests.
- The hot tub is checked twice daily to ensure chemical levels are within the safe limits outlined by gov.uk in its HSG282 guidance. For more information see here https://www.hse.gov.uk/pubns/books/hsg282.htm
- Despite the above protocol, chlorine, bromine and other hot tub chemicals within the safe limits can still cause skin irritation to those with sensitive skin, unknown allergies and/or by using the hot tub for longer than advised. Rossendale Holiday Cottages will not be liable for health complaints of this nature.
